BEACH PASS USAGE AGREEMENT SUMMER 2019

1. The Beach Pass Program is being offered again this year. These passes are accountable and must be safeguarded. To prevent loss or misplacement follow the below instructions to keep this program running smoothly. **YOU MAY BE REQUIRED TO SHOW YOUR MILITARY ID AT THE BEACH LOT.**
2. All Beach Passes are signed out **daily Monday – Saturday** from the Wings Inn Front Desk and **must be returned by 9:00 A.M. the following business day at the Wings Inn Front Desk or in the drop box.** If you are signing out a pass for the weekend, you will sign for the pass on Friday and return it on Monday morning by 9:00 A.M. Passes issued on Saturdays are also due back by 9:00 A.M. the following Monday morning. **Historically, if you'd like a pass for the weekend, it is recommended that you stop by Wings Inn Front Desk before 3 P.M. Friday.**

Note: The Wings Inn Desk will be closed Thursday, July 4th – passes for the holiday will be signed out Wednesday, July 3rd and returned by 9:00 A.M. Friday, July 5th. MWR will also be closed for the Coast Guard Day Picnic Friday, August 2nd – passes picked up on Thursday, August 1st will be due back by 9:00 A.M. Monday, August 5th, passes for Labor Day weekend will be signed out Thursday, August 29th and are to be returned by 9:00 A.M. Tuesday, September 3rd.

- A. Beach passes may be signed out from:
Wings Inn: Monday – Saturday 9:00 A.M. – 3:00 P.M.
 - B. You may call to inquire about beach pass availability, however passes may NOT be reserved and are issued on first come, first serve basis. For Saturday pick-ups, it is recommended you call the Wings Inn the morning *before* stopping by – to confirm availability. Wings Inn Front Desk: 508-968-6461.
 - C. ALL Beach Passes are to be returned to the Wings Inn during business hours or in the Beach Pass Drop Box in the entrance/lobby for before/after-hours returns.
3. Should you return a pass late you may lose beach pass privileges and your command may be notified.
 4. If the Beach Pass that you have signed out is not returned, the pass you had will be cancelled so that it will not be valid for use at any other time.
